Railroad Ditch System \$625,000

Priority #23 on HMGP List.

12/22/2020- Received ineligibility letter from FDEM regarding this project. Several emails have been sent following up on getting this back on the list and showing what benefits this project brings to the City.

Acme Lane \$325,000

Priority #84 on HMGP LIST

12/18/20- Received ditch survey from Dewberry that runs along backside of Acme Ln. Plan calls for roadside drainage ditch system.

Belaire Estates \$100,000

No work to date.

Bradley Circle \$290,000

Priority #67 on HMGP List.

11/23/2020- Dug ditch out in alley behind homes on Bradley Circle that ties into Jenks Ave.

Minnesota Ave \$150,000

12/16/2020- Met with Panhandle Engineering to review findings from what was gathered in the field and what they already had from the Master Plan evaluations. It was determined to move forward with design of a new ditch on the west side of Minnesota between 24th St and Pine Forest Estates.

12/21/2020- Emailed Wal-Mart staff to get easement on Minnesota Ave for proposed location of new ditch.

Krystal Ln \$30,000

12/18/2020- Entered PO for GCUC to vac and camera lines.

12/31/2020- GCUC cleaned and camera inspected stormwater lines. Lines had lots of debris and sediment in them causing stormwater to surcharge. Found point repair location 36' in from SWMH-1 on Kimberly Dr.; will repair this in-house. Hauled (7) truckloads of sand from this pipe.3 Engineer's Cost Opinion for cleaning and inspection-\$30,000. Staff completed for \$4,112.55



W 10th St 425,000

Priority #118 on HMGP List.

Virginia Ave \$120,000

Priority #96 on HMGP List.

12/9/2020- Signed proposal with Dewberry Engineers to begin surveys and legal descriptions to record easements on City outfalls and ditches. This area is under that list and work will commence after recorded easement is in place.

Sikes Construction completed December 2020 in the amount of \$302,610.70; Engineer's cost opinion was \$220,000.00

Florida Ave \$50,000

Priority #120 on HMGP List.

12/18/2020- Entered PO for GCUC to vac and camera lines.

1/4/2021- GCUC cleaned and camera inspected lines in area. No significant damage to pipe was found, conflict box on both sides of Florida Ave causes blockage of some of the storm drains. Conflict box access points have been paved over and will have to be exposed and raised. Engineer's Cost Opinion for cleaning and inspection-\$9,000. Staff completed for \$3,955.70

12/18/2020- Waiting on Push Button Contracts to be signed so point repair can be completed to remove 30%-40% blockage of RCP.

12/21/2020- Emailed DOT a request to clean their portion of the ditch out to allow for water to drain properly.

12/28/2020- DOT responded stating they would have ditch cleaned out.

15th St \$20,000

Priority #119 on HMGP List.

1/19/2021- Received PO for GCUC to clean ditches out from Florida Ave to Railroad Ditch utilizing push button contract. Gave Chris Corbin approval to move forward.

Plans were completed in July 2019.

12/17/2020- Kiki ran project by auditors, approval was given to spend impact fee money on this project if the Commission so desires to move forward with it. Met with Vickie about this project, wants to see how many affected flooded residents this project will benefit.

12/18/2020- Reviewed Hurricane Sally Flood Maps, no residents in this area flooded during Sally, had some flooding in 2013 and 2014.
